Foundations in public policy for engaged Indians

Overview

As economic growth propels India towards becoming a middle-income country over the next decade, it is imperative that its structures, processes and ideas of governance keep pace. Closing the governance gap requires talented individuals to be equipped with the right ideas, competencies and networks.

Takshashila's **Graduate Certificate in Public Policy (GCPP)** programme aims to equip dynamic Indians with knowledge, skills and exposure to public policy.

The 12 week course provides a firm understanding of the fundamentals of public policy and governance and enable participants to apply them in their professional lives and political discourse. The programme is designed to prepare participants to better engage in the public arena, as analysts, public officials, leaders or indeed, as active citizens.

Outcomes that matter

The GCPP Programme equips students with the knowledge of the policymaking process and the factors that influence it. They will acquire skills required to analyse policy in their own context and apply this understanding to their personal, professional and political goals.

Learning from the best

The faculty is drawn from Takshashila's international network of academic experts, practitioners and experienced professionals, making for an innovative, exciting and inspiring curriculum that both addresses the basics of the discipline as well as teaches skills that can be readily applied while engaging in public affairs.

Who should take this course

The GCPP Programme is primarily designed for citizens who want to take an active, more informed role in public affairs. It is open to qualifying individuals from any sector, discipline or

occupation. The programme meets the needs of those engaging in, or seeking to engage in a broad range of professions ranging from the media, civil service, non-government organisations, law, advocacy, regulatory affairs and international business.

Individuals and organisations engaged in consulting, social services, public health, economic development and international development will benefit from this programme.

A small number of junior studentships is available for promising undergraduate students who can add value to the class.

Schedule

The GCPP Programme consists of a 12 week blended learning programme. Most of the course will be conducted remotely using an online Learning Management System.

Structure

To successfully complete the course a student must:

1. Complete the two core modules
2. Either complete the elective or work on a policy research project of their own choice
3. Participate in the two weekend contact workshops. Pass a composite final examination.

Outcomes and Curriculum

An awakened, policy-educated Indian

What are the principal policy challenges India faces today? Does the popular discourse frame these problems accurately? Does the political system address the fundamental problems in an efficient and effective manner? How do we evaluate the manifestos, proposals and demands made by political parties, interest groups and civil society? How do we engage as empowered citizens to make a constructive contribution to India's future?

The GCPP Programme is designed to help dynamic individuals to navigate through the complex policy environment. Through networked self-study, lectures and interactive discussions, participants will gain a firm understanding of policy landscapes and emerge better equipped to play a competent role in public affairs.

Skills

Through the programme, participants will be better able to:

- Identify and understand India's policy environment
- Situate India's role as an emerging geopolitical and geoeconomic power within the context of its developmental challenges
- Apply economic reasoning in analysing public policy challenges
- Engage, negotiate with and partner with government, public and non-governmental organisations
- Forge effective relationships with policy actors and policy networks

Curriculum overview

Core Modules: Two core modules form the backbone of the course: *CP101 Introductory Public Policy Analysis* & *CP102 Economic Reasoning and Public Policy*. The lesson plan for these two modules stretches across 12 weeks, with prescribed readings, curated video lectures and assessments each week. The modules have been specifically designed by academic experts to suit the unique requirements of this programme.

Elective & Project: In addition, students can choose to complete an elective subject or alternatively propose and study a policy problem of their choice under *CP191 Policy Research Project*. Students who opt for the latter must obtain approval for their chosen topic within 15 days of the commencement of the course.

Weekend Policy Workshops: Two intensive weekends of lectures, seminars and policy workshops, (CP121 and CP122) tentatively scheduled for the fifth and tenth weekends are an integral part of the programme. These workshops bring together the class, faculty, outside experts and practitioners to impart knowledge, skills and nuances that go beyond purely online learning methods.

These workshops will be conducted Friday to Sunday and students are expected to make their own arrangements for travel and accommodation.

Special Arrangement: Students who are unable to attend these workshops for a genuine reason may apply for either deferment or opt to receive a Citation of Completion of Studies instead of the full GCPP. Subject to approval by the academic committee, the deferment can be valid for the next three intakes of the GCPP course.

Final Examination: Students must pass a composite final examination conducted at the end of the course.

Course Outlines

CP101 Introductory Public Policy Analysis

This module covers the analysis, design, evaluation and marketing of public policies in India. It has three broad components.

The first component deals with an overview of the normative and positive aspects of the Indian state and its governments and focuses on the roles, motivations and behaviours of the various players in the dynamics of policy making. It aims to provide students with a basic framework to understand how public policies are made in India.

The next component introduces key concepts and methods of policy analysis and provides a practical guide on how they might be applied to address India's developmental challenges.

The final component covers policy assessment and programme evaluation with an emphasis on analytical methods.

CP102 Economic Reasoning and Public Policy

This module concerns the application of economic reasoning to the design, implementation and outcome evaluation of public policies in India.

The module will first provide an overview of analytical insights and international experiences on factors contributing to sustained high long-term economic growth. It will then introduce the basic concepts of demand and supply, and how these can be used to analyse such policies as price controls, minimum wage, import and export duties, subsidies and others. The key point which would be emphasised is the need to maintain a reasonable balance between demand and supply in a dynamic context.

The module will then discuss the primary socio-economic function of public sector enterprises and organisations involved in providing basic amenities and services, such as roads, education, healthcare and waste management. This component will also introduce the key economic concepts relevant for public policies.

The rest of the module will focus on selected public policy areas and themes. These include: budgeting for results; reforming public sector enterprises; options for infrastructure development and maintenance; public-private partnerships; food security and agriculture; social protection policies; and India's urban challenges.

CP121 and CP122 - Weekend Policy Workshops

Tentatively scheduled for the fifth and tenth weekends, the weekend policy workshops will cover discussions over course material, contemporary issues and guest lectures over three continuous days (Friday to Sunday) each.

Electives

CP151 - Approaches to India's Key Development Challenges

CP152 – Fundamentals of National Security Policy

CP153 – Fundamentals of Foreign Policy

CP154 – Fundamentals of Geoeconomics

Each of the modules will understand the current situation, assess medium-term and long-term requirements, identify the key challenges and discuss policy solutions.

(Elective) CP191 - Policy Research Project

This is a guided self-study module where students can propose to conduct an in-depth study into a topic of their own choice, and apply the frameworks, techniques and methods taught in the core modules.

The course will be assessed based on the submission of a policy paper of around 3000 words along with a one page executive summary. This must be submitted by the end of the 12th week.

Students opting for this module must secure approval for their topic within 15 days of the start of the course. If the topic is not approved by that date, students must take CP151 instead.

Admissions Policy

Takshashila seeks candidates who are deeply committed to transforming India for the better by engaging in public affairs. It welcomes applicants from any discipline, geographical location occupation or age group.

Eligibility

A bachelor's degree in any discipline. While the course is not maths-intensive, 10th standard (or equivalent) level of mathematical skills is necessary. The course will be conducted and assessed in English.

Full-time undergraduate students are welcome to apply for *junior studentship*. A few places have been set aside to encourage and prepare younger people to take an active interest in public affairs.
